- 5. COUNCIL'S SCHEME OF DELEGATION

In view of developments relating to Coronavirus the National Association of Local Councils recommend that local councils consider what actions might help mitigate any risks to the council. This includes:

- Reviewing its Scheme of Delegation to ensure it is fit for purpose and would ensure minimal
 disruption to the work of the Council if Councillors are not able to attend meetings and committees.
 Certain decisions may be delegated to the Clerk/RFO (Locum Clerk/RFO), in consultation with the
 Chairman and Vice-Chairman, as a contingency plan in case council meetings are postponed due
 to the coronavirus
- Reviewing critical functions or services and consider how these would continue in the case of staff absence
- Signposting local residents with queries about coronavirus, to information from Government The following are suggested recommendations for consideration:
 - To note that it is lawful for the Clerk/RFO (Locum Clerk/RFO) to spend against specific items in the Parish Council's budget e.g. for contractors, hall hire, clerk's salary, all of which having been identified in the budget when setting the precept. Any such payments shall be reported to the Council at the next ordinary meeting.
 - To approve provision of delegated powers to the Clerk/RFO (Locum Clerk/RFO) to spend up to a limited amount £2,000 and to authorise urgent work when unforeseen circumstances occur in consultation with Chair & Vice Chair.
 - To delegate powers to the Clerk/RFO (Locum Clerk/RFO) to respond to planning applications (councillors are still able to submit their own personal comments)
 - To postpone the meeting of the Council on 14 April 2020, subject to Government ruling, should this be required.
 - To agree to receive and act upon Government advice (or ruling) in relation to the holding
 of the Annual Meeting of the Parish Council scheduled to meet on 11 May 2020 (noting
 such meetings must be held in May), thereby giving delegated power to the Clerk/RFO
 (Locum Clerk/RFO) to make necessary re-arrangements for these meetings in
 consultation with the Chair.

Each of these delegated powers could be worded in consultation with the Chair and Vice Chair (and Chairs of Committees) as required.
