#### 7. SHROPSHIRE COUNCIL'S DRAFT HOUSING ALLOCATION POLICY FOR CONSULTATION Parish Council submitted the following comments:

"Pontesbury Parish Council supports the draft housing allocation for affordable homes. It presents a comprehensive, clear, transparent, and fair procedure for tackling the problem of more applicants for affordable housing than there are houses currently available. We do have two possible concerns : other than under 23.2 no mention is made of circumstances when local people will be given priority over those outside a parish and whether those unable to access the appropriate technology will be adequately catered for in the notification process."

## Shropshire Council responded as below:

"With respect to local people with a connect to the parish being given greater priority than other people, under housing legislation, this can only happen when a specific local lettings policy in place (section 23). The usual example relates planning policy where affordable housing is delivered on exception sites (section 23.2), but local lettings policies can be introduced in other instances, however, it has to be ensured that these policies are introduced for specific reasons and they must comply with housing legislation. I am more than happy to chat through this ... if this would be of help? In terms of access to technology, paper copies of the application form are available and an assisted bidding service is

offered. But I agree that the wording of the policy needs to reflect that people may not have access to IT."
