PLAN 56.22.1 **Planning Decisions for Pontesbury Parish Council Area:** Planning decisions for the area were duly **NOTED.**

PLAN 56.22.2 **Planning Applications for Pontesbury Parish Council Area:** The Planning Committee considered the applications put before them and made the following decisions:

Planning Reference	Comments
22/04040/FUL Affordable dwelling, North East of Pontesford	SUPPORT : The Parish Council approve of the interesting design. The council felt that the design could be improved further with a little more detail to the front elevation such as brick work on the quoins.
22/04617/FUL Old Rectory, Brookside, Pontesbury	SUPPORT: The Parish council support the application but do feel there is a potential invasion of privacy from the top of the external staircase and would recommend some screening at the top of the stairs to minimise this. They also feel that given the glazed door that two velux windows in the roof is excessive.
22/04727/FUL Lingholm, Woodhall Drive, Hanwood	SUPPORT: The Parish Council support the application as they feel that sufficient steps have been taken to address the concerns made regarding the previous application such as including a continuous roofline and with the proposed eaves remaining at the same height. The council feel that the overall design will improve the general appearance and aesthetic of the property.
