a) 19/04859/FUL | Erection of single storey extension | Lilac Villa Top Road Pontesbury Shrewsbury SY5 0YE

Comments: The parish council supports this application which will give an improved visual appearance in terms of design and has no significant infringement of the amenity of neighbouring properties. The plot size is adequate for this proposed development which is limited in size.

b) 19/05117/FUL | Erection of single storey rear and side extension | 9 Brook Road Pontesbury Shrewsbury SY5 0QZ Comments: The parish council supports this application which will improve the visual appearance of the property. There is ample garden space for the proposed extension and no significant negative impact on the amenity of the neighbouring properties.

c) 19/05116/FUL | Erection of a two storey rear extension following removal of existing and demolition of detached garage | 5 Shorthill Lea Cross Shrewsbury SY5 8JD

Comments: The parish council supports this application for a well- designed extension which will enhance the appearance of the property. There is no significant impact on neighbours as the new windows face open field.
