 a) 19/05263/FUL | Erection of a detached double garage | Lingholm Woodhall Drive Hanwood Shrewsbury SY5 8JU

Comment: The Parish Council supports this application for a well-sited development which will have minimum impact on the landscape and amenity of neighbouring properties. In light of the concerns expressed by a number of neighbours about surface water issues, we would urge that the planning officers take this forward and act on the neighbours concerns and ensure that an adequate drainage system be reinstated on the site.

b) 19/05264/FUL | Erection of detached self-contained annexe ancillary to the existing dwelling | Lingholm Woodhall Drive Hanwood Shrewsbury SY5 8JU

Comment: The Parish Council supports this application for a well-sited development which will have minimum impact on the landscape and amenity of neighbouring properties. In light of the concerns expressed by a number of neighbours about surface water issues, we would urge that the planning officers take this forward and act on the neighbours concerns and ensure that an adequate drainage system be reinstated on the site.

In addition, in terms of a precedent being set, we note that the need for the annexe has been demonstrated but request that a condition that the annexe be tied to the existing property, be included.

Comment: The Parish Council supports this application for much needed maintenance and rebalancing of this group of trees. We reluctantly also support the felling of the two oak trees for safety reasons due to the proximity of the footpath.
