# 316.18 MINUTES OF COUNCIL

The minutes were submitted and circulated as read. Cllr B Morris wished to amend the minutes of the meeting on 11/3/19 to read that he was present and to remove names of previous councillors from the list. It was proposed by Cllr S Lockwood and seconded by Cllr B Morris and RESOLVED that the minutes of the Council meeting, held on 11<sup>th</sup> March 2019, be approved and signed as a correct record to include the above amendments.

# 317.18 PUBLIC QUESTIONS AND COMMENTS

A resident of Pontesbury raised the issue of parking outside Lunt's Chemists was affecting their business. Cllr N Hignett had met with Site Manager for Shropshire Homes to discuss this matter and would highlight the ongoing issues with Shropshire Homes.

A resident of Pontesbury raised the issue of road traffic accidents on the road between Pontesford Bridge and Plealey. Cllr N Hignett would raise the issue with the Shropshire Council Highways team.

#### 319.18 SHROPSHIRE COUNCIL MEMBER REPORT

Cllr N Hignett (Rea Valley ward) gave a verbal report including the following items;

- Shropshire Council has submitted two bids for funding from the 'Future of the High Streets Fund' for Shrewsbury and Oswestry.
- Heritage Infrastructure Fund Shropshire Council has been awarded £9.32m for the improvements to the Mile End roundabout in Oswestry
- Strategic Highways It has been confirmed that SC are to receive £54m towards the North West Relief Road. The total cost is £71m and completion date March 2024
- Potholes SC had been awarded £1m from the Pothole Fund.

# 320.19 PLANNING COMMITTEE

- i)The minutes from planning committee meetings held on 4<sup>th</sup> March & 1<sup>st</sup> April 2019 were received and **ADOPTED.**
- ii) Cllr A Hodges, Chairman of the Planning Committee, had sent his apologies but wish to highlight the strong feelings of the Pontesbury Parish Council Planning Committee about the proposed changes to the Shropshire Council Planning Committee structure.
- iii) Proposed changes to Shropshire Council Planning Committee Cllr N Hignett reported that there were ongoing discussions to reduce the number of Shropshire Council planning committees from three to two. It was felt that in the first instance, as there is no formal consultation process at this time, that Clerk should be asked to write to Professor Mark Barrow to express the concerns of Pontesbury Parish Council namely;
  - Geographic remoteness local knowledge is very important for decision making and this may be diluted with committees covering larger geographic areas
  - A concern that less items may go to committee which would take away the democratic process whereby local consultees make their views known

#### 321.18 ENVIRONMENTAL MAINTENANCE GRANT APPLICATION 2019-20

It was proposed by Cllr D Gregory and seconded by Cllr J Pritchard and RESOLVED to APPROVE the recommendations by Pontesbury Parish Council Planning Committee to submit an application to clear various path/cycleways around the parish to enable residents to use them more safely. Delegated authority approved for Cllr R Evans, Cllr N Hignett, Cllr D Fletcher and Clerk to complete application and submit by 30 April 2019.

#### 322.18 COMMUNITY INFRASTRUCTURE LEVY

The meeting was advised that the Neighbourhood Fund allocation due to be paid in April 2019 is £27,186.41 and this was formally **NOTED**. It was proposed by Cllr J Pritchard proposed and seconded by Cllr D Jones and **RESOLVED to approve the completion of the Neighbourhood Fund – Annual Report form in accordance with National ClL Regulations.**

# 324.18 SHROPSHIRE COUNCIL PUBLIC TRANSPORT CONSULTATION 25/03/19-6/05/19

It was proposed by Cllr S Lockwood and seconded by Cllr R Martinali and RESOLVED to APPROVE a response from Pontesbury Parish Council to include the following points and delegated authority to Cllr D Gregory, Cllr J Pritchard, Cllr D Jones, Cllr D Fletcher and Clerk to submit a final response by 6/5/19;

- An error on the consultation letter about the number of journeys between Shrewsbury and Bishop's Castle
- The proposed changes to charges on P&R such as the removal of group travel concessions, will negatively affect business and trade in Shrewsbury especially as it accompanies an increase in parking charges

- Central government have pledged to put money into making local bus services digital, this
  makes no sense if public transport in rural areas is massively reduced
- The cuts make no sense in relation to the government/Shropshire Council policy to increase the number of affordable homes in rural areas people on low incomes can be reliant on rural transport services to access employment
- The cuts also go against local and national sustainability/green policies by increasing car
  journeys for health, employment, education and social purposes
- Young people and elderly people will be disproportionately affected by the proposed cuts
- The reduction of Phlox Green to Bishop's Castle services will negatively impact on students attending school/college
- In summary Pontesbury Parish Council is totally opposed to the proposed cuts to public transport by Shropshire Council

# 325.18 GDPR UPDATE FROM DATA PROTECTION OFFICER

Written report was **NOTED** which included the need for cyber security awareness training for clerk and councillors and for any Data Breach or Subject Access Request to be reported to the DPO immediately. It was proposed by Cllr N Hignett and seconded by Cllr D Gregory and: **RESOLVED**: to renew the contract with JDH Business Services as Data Protection Officer for the financial year 2019- 2020. Clerk was asked to investigate what insurance cover there is for a data breach.

# 326.18 COMMUNITY HUB WORKING GROUP UPDATE

A verbal report was received from Cllr D Fletcher and **NOTED**. It was proposed by Cllr D Gregory and seconded by Cllr J Pritchard and **RESOLVED to APPROVE the recommendation from the Community Hub Working Group to appoint Steve Michie Electrical Ltd to carry out the IT wiring for the new community hub building.** 

A verbal report update from the Library Steering Group meeting was received from Cllr D Fletcher and **NOTED.** There will be a public meeting about the community hub building on 13/6/19. A site visit for Pontesbury Parish Council councillors is also planned for May.

# 327.18 ELECTION BY CO-OPTION OF A PARISH COUNCILLOR FOR PONTESBURY WARD

One application had been received and written information from the candidate had been sent out with the agenda papers. It was proposed by Cllr J Pritchard and seconded by Cllr D Gregory and RESOLVED to co-opt Mr Paul Bradbury to Pontesbury Parish Council, representing Pontesbury Ward.

# 328.18 SHROPSHIRE HOMES MAINTENANCE AGREEMENT

It was proposed by Cllr B Morris and seconded by Cllr R Martinali and RESOLVED to APPROVE transfer of the freehold for the public open spaces on the new Hall Bank development to the ownership of Pontesbury Parish Council. Shropshire Homes will continue with their management of the wildlife corridor for the first five years. £65,000 will be given to Pontesbury Parish Council for the purposes of the maintenance of the public open spaces. Delegated authority given to Cllr D Fletcher, Clerk to sign transfer agreement. Clerk asked to clarify the ownership of the public footpath at the bottom of Hall Bank.
