311.18 TREE INSPECTION AND MAINTENANCE CONTRACT

Advice was sought from Shropshire Council and Came & Company (Pontesbury Parish Council insurers) about the frequency of inspections and expert advice required to ensure that Pontesbury Parish Council meet all Health & Safety and insurance requirements for the trees they are responsible for. Three companies had been approached and two had submitted quotes.

It was proposed by Cllr D Gregory and seconded by Cllr J Pritchard and RESOLVED to APPROVE the following recommendations by the working group (Cllr D Fletcher, Cllr N Lewis and Clerk);

- Specialist inspection and expert advice to be sought from an Aboriculturalist to include the following;
- An inspection report about the current health of the trees Pontesbury Parish Council are responsible for
- A recommended specialist inspection timetable for the future (in writing)
- A recommended routine visual inspection timetable (including frequency and content) (in writing)
- Prioritised recommendations for tree works to be carried out to meet health & safety obligations between April 2019 and the next recommended inspection
- Advice about the small woodland next to the Sports Area (this may need an additional separate survey)
- 2. Delegate authority to Clerk, Cllr D Fletcher and Cllr N Lewis to seek quotes from 3 (Shropshire Council approved) contractors for the scheme of work identified in 1. above.

Any contractor appointed will be;

- Asked to carry out the regular, routine visual checks identified under 1.
 above (especially following bad weather) and provide a written record of these checks
- Asked to provide evidence of risk assessments, health & safety policy and public liability
- 3. Delegate authority to Clerk, Cllr D Fletcher and Cllr N Lewis to carry out further investigation into the future management of the small woodland next to the Sports Area, following advice by aboriculturalist appointed, and to report back

to a full council meeting with recommendations

It was proposed by Cllr C Sandells and seconded by Cllr J Pritchard and RESOLVED to APPROVE appointment of Shropshire Council tree team led by Martin Sutton to carry out the expert inspection.

Cllr D Fletcher wished to minute his thanks to Cllr N Lewis for all his hard work and advice on tree matters.
