183.17 POLICE REPORT

PCSO Joe Bradley gave an overview of recent Police activities and answered questions from members.

184.17 SHROPSHIRE COUNCIL MEMBER REPORT

Cllr R Evans gave a verbal report, which included information about an upcoming consultation on Shrewsbury's North West Relief Road and the launch of Shropshire Council's Economic Strategy. Shropshire Council's Local Plan review consultation documents will be considered by Cabinet on 18th October and will be available online prior to this meeting. There had been discussions at the Police Crime Panel meeting about changes to the signage for Community Speed watches and an update was given on the Police Crime Commissioner's plan to take over governance of the Fire and Rescue Service and a motion had been passed to ask him to withdraw these proposals. Shropshire Council will be publishing its Finance Strategy shortly.

185.17 PLANNING COMMITTEE

The minutes from planning committee meetings held on 4th September 2017 were received and **ADOPTED.**

Cllr A Hodges, Chairman of the Planning Committee, gave a verbal update which included information on recent planning applications and decisions. The meeting was given a verbal report on the recent Neighbourhood Plan training which Cllr A Hodges, Cllr D Fletcher and the Clerk had attended.

186.17 LAND AT HALL BANK, PONTESBURY

A report about the pre-application consultation from Shropshire Homes at the recent Planning Committee meeting was circulated with the agenda papers. The main details of the proposals were considered and it was noted that Shropshire Homes had offered to build a community hub as part of the new proposed site. The meeting was advised that a public awareness event had been organised with Shropshire Homes. There was a discussion about the proposals and it was agreed that it was important to raise concerns about the changes to site access at pre-application stage to allow Shropshire Homes to consider this before an application is submitted.

RESOLVED that the Clerk should write to Shropshire Homes to advise them that the Parish Council welcomes the proposal to build the Community Hub and the informal comments made by the Planning Committee were supported by the full Council but members of the full Parish Council also expressed concern about the proposal to have only one access in and out of the residential element of the development at the bottom of Hall Bank, rather than two as per the outline. The separate access to the non-residential elements is supported, but the Parish Council anticipates strong community concern/comment about reducing the access to the houses to one two way access, particularly because this is the access at the bottom of Hall Bank.

192.17 SHROPSHIRE ROAD SAFETY POLICY

A draft community concern submission based on the previous year, which had been circulated with the agenda, was considered together with letters from local residents. It was noted that a request to extend the 30mph through Cruckton and restrict HGVs had previously been included for consideration and was on the draft submission. It was suggested that the hedge at Cruckton could be replaced with a wire fence and Cllr A Hodges was asked to speak to the land owner.

RESOLVED to submit the circulated draft community concern locations and include the following additional concerns:

i. Include suggestion from Plealey resident that the road from Plealey to Halston Cottages be made one way downhill for its entire length to a point immediately before and adjacent to the entrance to Spring Lea fisheries.
